1. **Scope of Services.** Instructor agrees to provide Participant with 30 hours of classroom, Permit test and 6 hours of behind the wheel instruction designed to meet the requirements of the state of Colorado ("Drivers Education Program"). Classroom dates and times are available on our website at [www.anshordriving.com](http://www.anshordriving.com). **If any classes are missed, they can only be made up the next time the session is offered.** Online Courses offered \$125. 2. **Payments.** Student Agrees to pay for the course in which they were in enrolled.
3. **Code of Conduct.** The code of conduct attached to the addendum and incorporated by reference is applicable to the Participant at all times during classroom and behind the wheel instruction. **Student expressly acknowledge that failures of the participant to abide by the code of conduct may result in termination of this agreement and immediate dismissal from the driver's education Program. In the event of such dismissal, all fees Paid to Anshor are non-refundable .**
4. **Refund Policy.** Anshor driving school strives to offer you the highest level of service. We honor our commitments to you and expected our customers/students to do the same. The level of commitment to the community requires us to have a no-refund policy. That means once you paid and registered through education/training at Anshor Driving School, there will be absolutely **no refunds**. INITIALS \_\_\_\_\_.

5. **Insurance.** Anshor agrees to carry and maintain effect, at all times throughout the performance of this of this agreement, insurance coverage, including contractual liability for bodily injury, death, and property damages. Such insurance coverage shall provide a single occurrence limit of not less than \$50,000
6. **Limitation of liability.** Anshor and instructors shall not be liable for any indirect, incidental, special punitive or consequential damages for any breach of this agreement  
Student exclusive remedies for any and all claims related to the services provided by Anshor under this agreement shall be limited to the total payments made for the driver's education program
7. **Notices.** Between Anshor and the student will be via email.
8. **Assignment.** The student shall has no rights to assign its their respective rights and obligations under this agreement.
9. **Governing the law of State Of Colorado.** This agreement is constructed and enforced in accordance with the laws of State Of Colorado
10. **Amendments** No change or modification of this agreement will be valid unless the same is in writing and signed by the Parties.
11. **Severability.** If any section paragraph , cause of this agreement shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section paragraph clause or provision shall not affect any of the remaining provisions of this Agreement, the intent being that the same are severable.
12. **Cancellation fee.** Instructors plan to keep all scheduled lessons with students and classroom times and reschedule accordingly when necessary. A Cancellation fee of \$30 dollars will be charged for any cancellations of behind the

wheel lessons with less than 48 hours' notice. This will be added to the student's account . We will charge the fee for the following reasons:

If you fail to show for your scheduled lesson or class without calling /canceling online at least 48 in advance.

Forget to bring your permit or your licenses to your driving lesson

Show up more than 15 minutes late for your behind the wheel lesson Initials \_\_\_\_\_.

**ADDENDUM1**

1. Proper attire must be worn at all times . No hats in the classroom. No spaghetti straps on shirts and midriff must be covered.
2. Any damage to Textbooks will be the responsibility of the student. Replacement cost of textbooks will incur a charge of \$40 WRITING ON DESKS OR CHAIRS WILL BE GROUNDED FOR EXPULSION.
3. IMPROPER LANGUAGE WILL NOT BE TOLERATED IN THE CLASSROOM.
4. NO FOOD IN THE CLASSROOM OTHER THAN LUNCH, WATER DRINKS WITH SEALED LIDS ARE ALLOWED. SPILLS MUST BE CLEANED UP IMMEDIATELY BY STUDENT.
5. CELLPHONES, CD PLAYERS OR IPODS MUST BE TURNED OFF DURING CLASS.
6. CONVERSATIONS IN THE CLASSROOM MUST BE LIMITED TO ANSWERING QUESTIONS BY THE INSTRUCTOR , UNLESS WE ARE WORKING ON A GROUP PROJECT. STUDENTS SHOULD SHOW PROPER RESPECT TO EACH OTHER AND THE INSTRUCTOR.
7. NO SMOKING OR VAPING IN THE FACILITY OR WITHIN 150' OF THE FACILITY. ZERO TOLERANCE FOR DRUGS AND ALCOHOL.
8. PROVIDE 48 HOURS NOTICE IF YOU NEED TO CANCEL OR RESCHEDULE YOUR LESSON. LATE CANCELLATIONS WILL RESULT IN A RESCHEDLING FEE.
9. ANSHOR IS NOT RESPONSIBLE FOR STUDENTS WHO LEAVE THE CLASSROOM FOR LUNCH. ALL INSTRUCTORS WILL BE AVAILABLE IN THE CLASSROOM FOR STUDENTS WHO CHOOSE TO STAY FOR LUNCH. STUDENTS WHO LEAVE FOR LUNCH MUST BEHAVE IN AN APPROPRIATE MANNER AT ALL TIMES. MISCONDUCT MAY BE GROUNDED FOR EXPULSIONS.
